## STANDARD PROTECTION FOR USED TRANSMISSIONS/TRANSFER CASE

Transtar Industries, Inc. provides this Limited Warranty on the above-identified qualified use transmission purchased from and installed by an authorized Installer in the United States. This Limited Warranty is solely and exclusively for the specific transmission installed in the vehicle listed above. This Limited Warranty is transferable from the original retail purchaser, to legitimate subsequent owner(s) of the vehicle residing and operating such vehicle within the United States; but, the warranty coverage date and mileage calculation begins from the date and mileage of the original installation noted above.

**Warranty Period:** 90 Days parts replacement only from original installation. Repair, replacement or transfer does not extend the Warranty beyond the original period.

**In order to validate your warranty, the following must be installed prior to installing your replacement transmission for warranty to be valid:**

Those items include but are not limited to: **New Gaskets, New Seals, New Filter, New Fluids, Sensors and Switches.**

**Warranty Coverage:** Transtar will repair, replace or refund the original purchase price of the transmission, at Transtar's sole option and discretion, if the transmission is found to be defective in design, materials or workmanship, subject to the following terms, conditions and limitations:

- This Warranty does not cover failure due to improper installation or repair, unauthorized disassembly, abuse, misuse, contamination, modification of transmission and/or vehicle (beyond original design limits), lack of proper maintenance, neglect, accident, vandalism, overheating, use of vehicle in competition, racing events, off-road, commercial, fleet or business purposes or other than originally intended or authorized, or any other condition other than defect in design, materials or workmanship.
- This Warranty does not cover parts or components that are replaced as part of normal maintenance, cosmetic, or parts or components related to, but not part of, the transmission (including damage to the transmission that may be caused by those related parts or components).
- To the extent allowed by law, damages are limited to the original purchase price. Loss of time or income, inconvenience, cost to return the vehicle/transmission to the designated installer, towing, storage, loss of use of the vehicle, rental, fuel, telephone, travel, meals or lodging, commercial loss, injury to person or property, damages to other related/unrelated parts, and incidental, special, punitive, liquidated and consequential damages are not covered by this Warranty.

**To Get Warranty Service:** Take your vehicle back to the Installer listed above for the initial Check-Up and any subsequent service. Present the Installer with this Warranty and the repair order showing proof of purchase of the transmission and the vehicle's mileage at the time of installation. If distance prevents the return to the Installer, contact the Transtar Customer Service Center at 877-526-6567.

**Prior Approval Required:** The Installer must call the Transtar Customer Service Center at 877-526-6567 for authorization prior to repairing or replacing the transmission. Failure to obtain authorization will result in denial of claims.

THIS WARRANTY IS THE SOLE WARRANTY WITH RESPECT TO THE TRANSMISSION AND SUPERSEDES ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE. TO THE EXTENT THAT APPLICABLE LAW PROHIBITS THE WAIVER OF THE IMPLIED WARRANTIES OF MERCHANTABILITY AND/OR FITNESS FOR ANY PARTICULAR PURPOSE, SUCH IMPLIED WARRANTIES ARE LIMITED TO THE DURATION OF THIS WRITTEN LIMITED WARRANTY.

Failure by Transtar to exercise any right, or failure to enforce strict performance hereunder, shall operate as a waiver thereof or preclude the exercise of any other right; the rights and remedies reserved herein shall be cumulative and additional to all other rights and remedies available to Transtar in law or equity. Transtar and its suppliers reserve the right to make changes in or additions to transmissions remanufactured for or sold by Transtar at any time without incurring any obligation to make the same or similar changes or additions to transmissions previously remanufactured or sold. This Limited Warranty is governed by the laws of the state in which the transmission was purchased.
